

Remote Indoor Control

MODEL: IC-321WH

*For use with one (1) NuTone 25 ohm speaker only.

For use with IM-3204 Series Radio-Intercom System to operate IS-82, IS-76 or ISA-78 Series 25 ohm speakers only.

- This model is designed for INDOOR use only. Use Model IC-321WHW for outdoor installation.

LOCATION

- The remote control should be located near the speaker which it will control and at a convenient operating height (approximately 50" to 60" from the ground.)

MOUNTING THE ROUGH-IN FRAME

- The remote control is designed to be recess-mounted with NuTone Model IR-91 Rough-In Housing. Refer to the instructions included with the rough-in for detailed mounting instructions.

WIRING

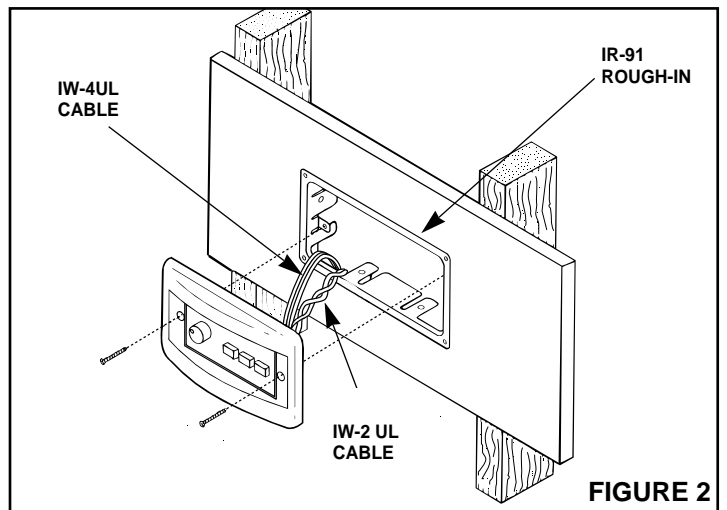
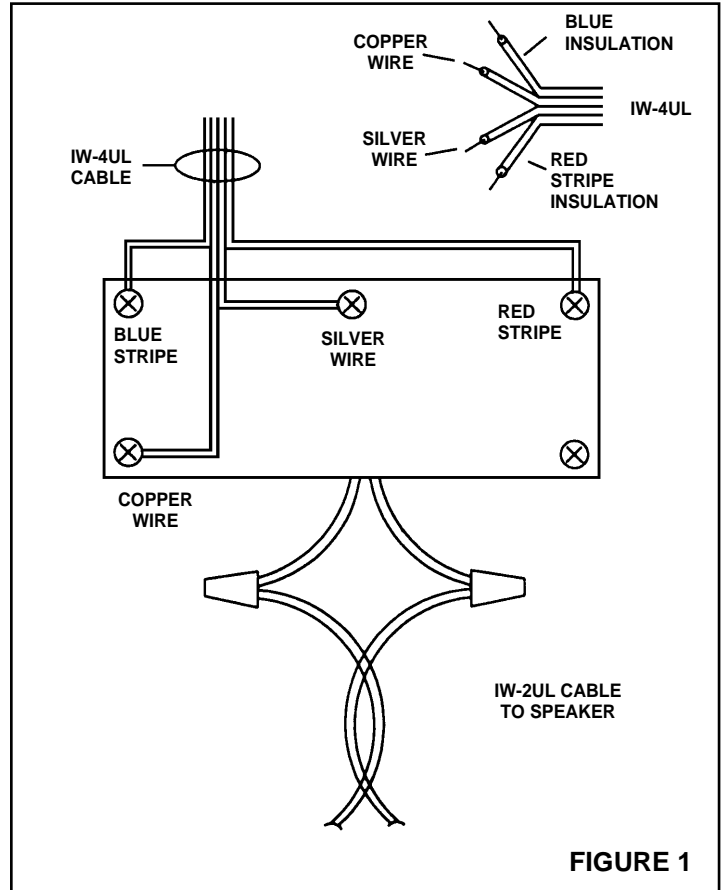
- Use only NuTone specified wire. Refer to the instructions included with the master station for complete system information.
- The remote control requires NuTone IW-4UL cable from the master station to the remote control location and NuTone IW-2UL twisted pair (22/2) cable from the remote control to the speaker.

Refer to Figure 1.

1. Connect color-coded wires (IW-4UL) from master unit to the matching terminal screws on the remote control's printed circuit board as follows: red stripe insulation wire to terminal marked RED STRIPE; silver wire to terminal marked SILVER WIRE; copper wire to terminal marked COPPER WIRE; blue insulation wire to terminal marked BLUE STRIPE.
2. If push-on terminals are attached to the ends of the remote control's speaker wires, cut off terminals and strip wires to make wiring connections to the speaker.
3. Connect IW-2UL cable from the speaker to the remote control's two speaker wires.

MOUNTING THE REMOTE CONTROL

1. Carefully place excess wire behind the mounting frame.
2. Refer to Figure 2. When finished wall is in place, secure the remote control to the rough-in with (2) mounting screws (furnished).

During this two year period, NuTone will, at its option, repair or replace, without charge, any product or part which is found to be defective under normal use and service. **THIS WARRANTY DOES NOT EXTEND TO FLUORESCENT LAMP STARTERS OR TUBES, FILTERS, DUCT, ROOF CAPS, WALL CAPS AND OTHER ACCESSORIES FOR DUCTING.** This warranty does not cover (a) normal maintenance and service or (b) any products or parts which have been subject to misuse, negligence, accident, improper maintenance or repair (other than by NuTone), faulty installation or installation contrary to recommended installation instructions.

The duration of any implied warranty is limited to the one year period as specified for the express warranty. Some states do not allow limitation on how long an implied warranty lasts, so the above limitation may not apply to you.

NUTONE'S OBLIGATION TO REPAIR OR REPLACE, AT NUTONE'S OPTION, SHALL BE THE PURCHASER'S SOLE AND EXCLUSIVE REMEDY UNDER THIS WARRANTY. NUTONE SHALL NOT BE LIABLE FOR INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES ARISING OUT OF OR IN CONNECTION WITH PRODUCT USE OR PERFORMANCE.
