

5" Patio Speaker with Controls

MODEL: IS-329 Series

- For use with the IM-3204 Series Radio-Intercom Systems.

LOCATION

1. Determine location for the speaker on outside of house – near patio, on porch, or other desired location.
2. Locate speaker at a convenient operating height approximately 4½ feet above ground.

MOUNTING THE FRAME

1. The mounting frame may be mounted directly to the exterior wall, or to a single-gang outlet box mounted in the wall.
2. Before attaching the mounting frame to wall, apply a continuous bead of caulk around the back edge of the frame.
3. Refer to Figure 1. Secure mounting frame to wall with two (2) #6 – 32 x 1¼" mounting screws.

WIRING

- Use only NuTone specified wire. Refer to the instructions included with the master station for complete system information.
 - The remote speaker requires NuTone IW-4UL cable from the master station to the remote speaker location.
1. Refer to figure 1. Pull wires through hole in back of frame.
 2. Refer to figure 2. Remove plastic clip that holds the rubber gasket to the printed circuit board.
 3. Refer to figure 3. Connect color-coded wires (IW-4UL) from master unit to the matching terminal screws on the remote control's printed circuit board as follows: red stripe insulation wire to terminal marked RED STRIPE; silver wire to terminal marked SILVER WIRE; copper wire to terminal marked COPPER WIRE; blue insulation wire to terminal marked BLUE STRIPE.
 4. Fold rubber gasket over terminal board screw connections. Secure the gasket to printed circuit board by sliding the plastic clip over the gasket and printed circuit board.

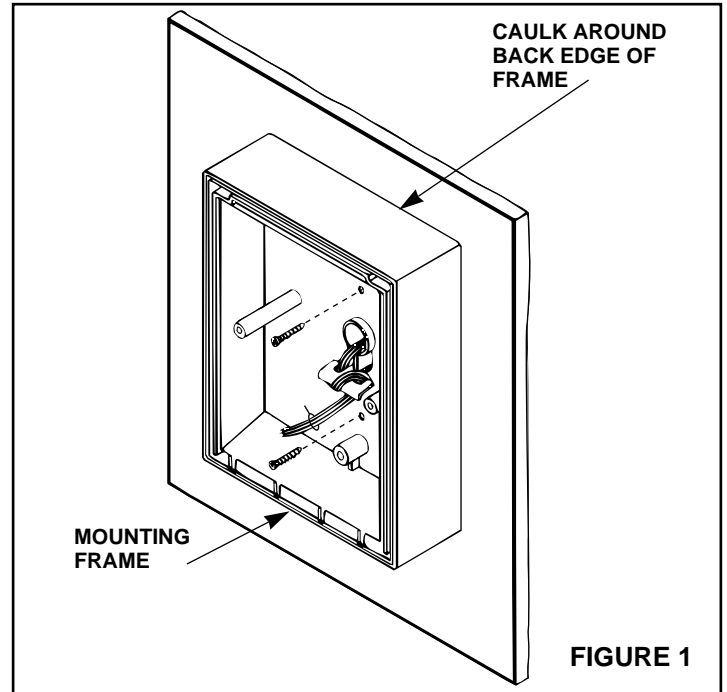

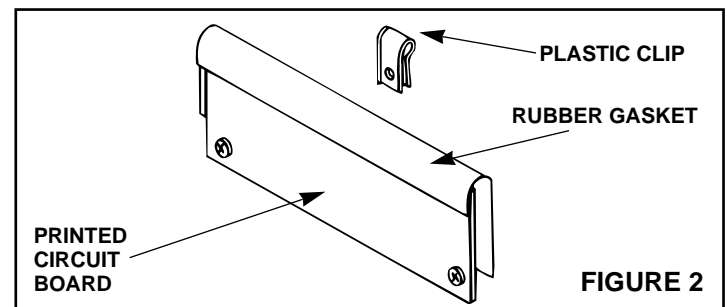

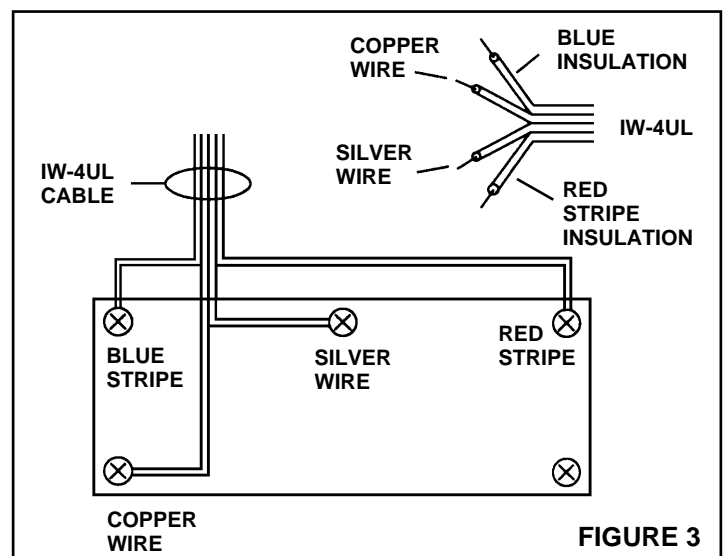

COMPLETING THE INSTALLATION

Refer to Figure 4.

1. Carefully place excess wire into mounting frame.
2. Place gasket (furnished) into groove of mounting frame. The gasket will fit into both side and top grooves. The bottom of the frame where the weep slots are should not be filled with the gasket material.
3. Place edge of the patio speaker into groove of the mounting frame. Make sure the patio speaker and frame fit together tightly.
4. Secure patio speaker to frame with two (2) #8 x 2" mounting screws (furnished).

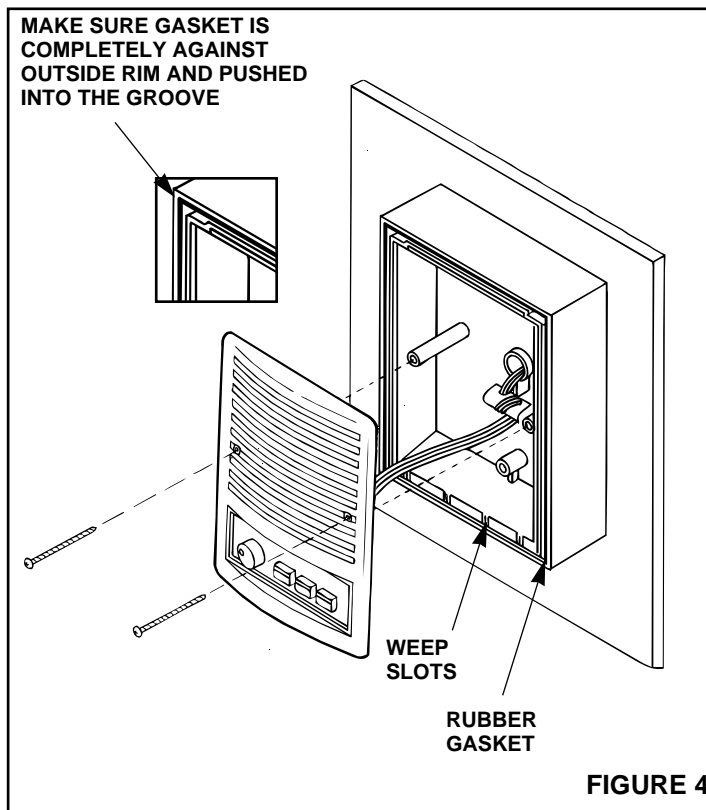

The duration of any implied warranty is limited to the one year period as specified for the express warranty. Some states do not allow limitation on how long an implied warranty lasts, so the above limitation may not apply to you.

NUTONE'S OBLIGATION TO REPAIR OR REPLACE, AT NUTONE'S OPTION, SHALL BE THE PURCHASER'S SOLE AND EXCLUSIVE REMEDY UNDER THIS WARRANTY.
